

<u>Judge Edward Hester Award</u>: recognizes outstanding local courthouse personnel who have been of particular assistance to the members of the local bar.

<u>Liberty Bell Award</u>: recognizes a non-lawyer for outstanding service in promoting a better understanding of our Constitution and Bill of Rights. The recipient encourages a greater respect for law in the courts, stimulates a deeper sense of individual responsibility so that citizens recognize their duties as well as their rights, and fosters a better understanding and appreciation of the rule of law.

<u>Robbie Robinson Award</u>: presented to a member of the legal profession who has demonstrated dedication to the principles of service to individuals and of advancement of the legal, political, social and civil rights of the citizens of the Savannah community.

<u>John B. Miller Award</u>: presented to a member of the Savannah Bar who is selflessly dedicated to making the Savannah area a better place to live through volunteer community service.
