

The Conference will kick off on Friday at 1:30 p.m. with a symposium entitled "Legal Writing: A Doctrinal Course." Prominent scholars in the field of legal writing will be presenting papers and discussing trends in the profession and best practices for developing the identity of the discipline. Practitioner's Corner: Practice Tips From Local Bar Members

Real Estate Closing Practice Hints for Owner Occupied Property By: Steve Greenberg

A very important aspect of a residential closing is the ability to provide a purchaser with important and valuable information. It not only makes the homeowner a more knowledgeable person but also reflects well on you and your attention to the details of closing. One of those very valuable items of information is the Homestead Exemption. The web site of the Chatham County Board of Assessors has several pages of information dealing with various types of assessments. For the regular Homestead Exemption, it is easy enough to print the page then provide it to the purchaser. There is also information on the Stephens-Day exemption and that should also be pointed out. In that way, material is delivered at closing on the exemptions, the application requirements, and the time to file. It is then obviously up to the purchaser to go to the courthouse and apply. Likewise, on refinances, check the title notes and see if there is an indication of Homestead Exemption. If not, then you will be helpful to the homeowner to ask if an application was made in the past. It is not unusual to find a person who meant to file but never did. By reminding that person, you really have provided a benefit that is not only an aid but results in much good will. Finally, always remember that the parties should understand that you represent the lender. While the information you are providing is a true service, it is only gratuitous and should not be construed as anything but that.
