



## Savannah-Chatham County Recorder's Court Amnesty Program

The Savannah-Chatham County Recorder's Court will hold an Amnesty Program from August 15, to September 15, 2014. During this time, individuals having **Contempt Fees** on traffic citations will be given the opportunity to pay the base fine plus court cost, thus waiving the **Contempt Fees**. Also during this time all mandatory court appearances will be rescheduled at no cost. Any citation not requiring a court appearance must be paid in full, no payment plans will be given without a court appearance. Citations will not be rescheduled or paid via phone or internet. All interested parties must visit the Savannah-Chatham County Recorder's Court, Mon-Fri, 8:15 a.m.-4:45 p.m.

## Savannah Law School Increases Diversity in its Third Year

Savannah Law School is pleased to welcome its third entering class! With applications shrinking nationally at a rate of 8.2%, Savannah Law School bucked the trend again this year as

applications to the law school increased by 18%. With a gender distribution of 71% female and 29% male, 21% minority representation, 17% military veterans, and a median age of 26, the 2014 entering class is Savannah Law School's most diverse; thus reinforcing the school's mission of providing the opportunity for legal education to both traditional and non-traditional students who show promise of making positive contributions to the profession, legal system or society.

grounds. 64% of incoming students come to Savannah from states other than Georgia, such as, Alaska, Arizona, California, New York, Ohio, Oklahoma, Maryland, South Dakota, Tennessee, and West Virginia. 33 different undergraduate institutions are represented, such as, Michigan State University, Texas Tech University, U.S. Military Academy, U.S. Naval Academy, and the Universities of Alabama, Alaska, Colorado, Georgia, Florida, Minnesota, North Carolina, and South Carolina. Students have also spent years serving throughout the world as

Army and Naval Officers, business owners, teachers, kayak guides, musicians, athletes, and parents.

You are cordially invited to attend the annual Red Mass to be held this year on **Friday**, **October 10**, **2014 at 12:00 noon at the Cathedral of St. John the Baptist** and the St. Thomas More Award luncheon in Lafayette Square immediately following the Mass.

The Red Mass is an historic tradition of the Catholic Church dating back to the 13th century when it officially opened the term of Court for most European countries. The celebrants, which included lawyers, judges and government officials, would proceed into a church clothed in red garments to signify the fire of the Holy Spirit to all who pursue justice in their daily lives.

St. Thomas More (1478-1535) is recognized as the Patron Saint of lawyers and is best remembered in secular society as the humanist who authored <u>Utopia</u> in 1516. As a youth he wrote bawdy poetry; as a statesman and lawyer he was brilliant, pragmatic and shrewd; as a father he favored a well-rounded education for all of his children, his daughters as well as his sons. As Lord Chancellor of England, St. Thomas More was executed by order of King Henry VIII when he refused to support the King's break with the Catholic Church. St. Thomas More loved literature, philosophy, mathematics, music and art. He had a keen sense of humor and provided a joyful home environment, welcoming friends to join his family in songfests and games. A Renaissance man, he had progressive views that he did not find in contradiction to his loyalty to the Church.

Each year the Lawyer's Guild presents the St. Thomas More Award to honor a person who exemplifies the qualities of St. Thomas More. The Red Mass is held to invoke divine guidance and strength for all who seek justice. The Most Reverend Gregory J. Hartmayer, OSF, Bishop of Savannah will be this year's main celebrant.
