Savannah Law School Receives American Bar Association Approval

Report from BASICS Committee Member Gwendolyn Fortson Waring

The Bar Associations' Support to Improve Correctional Services (BASICS) program was initiated in 1976 by the ABA, and twenty-two bar associations began BASICS programs around the country. Today, however, only the State Bar of Georgia's BASICS World of Work Program is still in existence. I was recently appointed to the BASICS committee, which is an advisory committee that reviews the operation of the BASICS World of Work program. The State Bar website describes the program's mission as follows: "to aid and steer inmates in the direction of self-rehabilitation" by assisting with career development, educational and/or work plans and upon release assisting with job search application for college and vocational schools as well as developing financial plans, with the goal of decreasing the likelihood that these individuals will return to jail.

On December 6, 2014, I had the honor of representing the State Bar at the Augusta Transitional Center graduation, one of five BASICS graduations held each Fall. The

participants, whose ages ranged from the late teens to mid-sixties, thanked me as a representative of the State Bar. I was particularly moved by one former inmate who said to me, "I really want to thank you for this program, because, last year at this time, I had nothing." The graduates' families attended, and it was the first time that many of the men had an opportunity to wear a cap and gown. Of the five graduations held statewide, the Augusta graduation was the only one held off-site and at a local church



because the pastor wanted the graduates to feel a "part of the community."

I hope to see a program such as this in the Savannah area and look forward to working to develop partnerships with local entities that support the BASICS mission. At the graduation, all in attendance were reminded that the graduates were "people who made mistakes, who needed a second chance, and who were determined not to let the mistakes define them." We have all made mistakes, and I for one am grateful that I was given opportunities to redeem myself.

I'm glad that our bar dues support this effort. The good news is that on July 1, 2014, sections 7 and 8 of Senate Bill 365 became law and relate to the codification of the responsibility of the Department of Corrections to create re-entry programs for adult offenders in the prison system. The BASICS committee is now looking at ways to expand the program in light of the legislation. For more information visit the site:
