Announcement Regarding Proposed Orders to Superior Court Judges

The Bench and Bar Committee of the Savannah Bar Association has been asked by the staff attorneys of the Superior Court, with the approval of the Superior Court Judges, to let all bar members know that it would be of assistance to the court and may help expedite rulings if Proposed Orders accompany the motions and responses thereto, either at the time of filing or immediately after oral argument, if scheduled. The Proposed Orders should be sent via email, in an editable format such as Word or Word Perfect, to the judge's administrative assistant, with a notation that the correspondence should be directed to the attention of the staff attorney. As with all correspondence to a judge or a judge's office, all counsel of record should be copied on the email. Each statement of fact recited in a Proposed Order needs to have an accurate and specific record citation, and where legal principles are stated in a Proposed Order, appropriate citations to statutes and case precedents should follow.

Report from Board of Governors Member Jon Pannell

The Board of Governors for the State Bar of Georgia held its winter meeting on Saturday, January 10, 2015 at the Marriott Marquis in Atlanta, Georgia.

After the consent agenda was approved, the Board of Governors took up several action items relating to bar rules and proposals from the Advisory Committee for Legislation ("ACL"). The first action item was some "housecleaning" items presented by Bill NeSmith to amend the State Bar bylaws relating to duties of State Bar officers. The changes were approved unanimously. Next, Bill NeSmith presented a detailed list of changes to the disciplinary rules proposed by the Disciplinary Rule and Procedures Committee. Many of the amendments were to clarify terms and provisions to make the rules more consistent and to clean up improper references, however there were some substantive amendments regarding sworn responses during discipline proceedings, costs of transcripts in disciplinary matters, and lawyers organized under alternative business structures and the sharing of fees by such lawyers. There were a few questions posed by the members of the Board of Governors about the proposed changes but after a brief question and answer session the changes to the disciplinary rules were unanimously approved.

The remaining action items taken up by the Board of Governors were presented by Dawn Jones, ACL Chair, and Thomas Worthy, Director of Governmental Affairs for the State Bar, relating to the 2015 legislative session. The Board of Governors approved supporting the Council of Superior Court Judges, District Attorney's Association of Georgia, and the Indigent Defense Committee efforts to raise salaries for the Supreme Court and Court of Appeals, all superior court judges, district attorneys and public defenders during the upcoming legislative session. There was some concern from some Board members that the salary increases may get lumped together and tied to one another during the budget process, but it was ultimately decided that the best course of action for the State Bar was to support the pay raises for all the proposals. Next the Board of Governors approved several legislative items proposed by sections of the Bar including revisions to the long arm statute, water lien legislation presented by the real property section, an uniform fiduciary act presented by the fiduciary law section, business corporation code amendments by the business law section, and the uniform unsworn foreign declarations act proposed by the international trade in legal services committee.

The last action item was presented by the President of the State Bar, Patrise Perkins-Hooker. The State Bar President presented the "Attorneys for Rural Areas Assistance Act" which is designed to attract private civil attorneys to rural areas, in particular six rural counties in Georgia who currently do not have a practicing attorney. The plan, if approved by the Georgia General Assembly, would combine incentives and assistance for young lawyers to locate in the six underserved counties to take on pro bono and reduced fee cases in addition to regular paying clients, in exchange for debt forgiveness for student loans. The program would be administered by the Georgia Department of Community Affairs and be subject to appropriation of funds from the General Assembly before awarding any loan forgiveness agreements standing for and against the proposal. Rucker Smith, a Superior Court Judge in the Southwestern Judicial circuit questioned the plan and stated that it was "too bureaucratic". Thomas Herman from Augusta commented that he liked the plan but thought the Bar's efforts could be better spent on strengthening Georgia Legal. Services. Donnie Gillis, a superior court judge from Dublin, also questioned the plan and questioned the "survival" rate of new lawyers in a rural area. After much discussion, a voice vote for approval was too close to call. The Board then took a vote by members of the Board. The plan was ultimately approved in a split vote of 74 in favor and 35 against.

Having completed the action items on the agenda, the meeting then turned to nominations for State Bar officers for 2015-2016. Pat O'Connor of Savannah was the first nomination from the floor to serve as Treasurer of the State Bar for the upcoming year. Pat was the only nominee for Treasurer. Following Pat's nomination, all other nominations for officers were also sole nominations, Buck Rogers of Atlanta for Secretary, Rita Sheffey of Atlanta as President-Elect, and Lester Tate and Donna Barwick to continue their posts as ABA delegates for the State of Georgia.

Following election nominations, information reports were made by the President of the Bar, Treasurer, YLD President, and by Phyllis Holmen regarding the Georgia Legal Services Program. Following the informational reports, Governor Carl Sanders and Kirk McAlpin, Sr. were memorialized for their contribution to the State Bar and the legal profession in Georgia.

The spring meeting of the Board of Governors will be held April 17-19 at Brasstown Valley Resort in Young Harris, Georgia.

Report from Board of Governors Member Gwendolyn Fortson Waring

The two most controversial items on the Agenda for Approval at the last Board of Governors' meeting were: 1) the proposal by State Bar President Patrise Perkins-Hooker to urge the State to provide incentives for lawyers to practice in areas of the State where there are few or no lawyers; and 2) the proposal to increase judicial salaries and as well as those of the District Attorneys and Public Defenders.

Seventy-percent of readers polled agreed that the State of Georgia should encourage more lawyers to work in rural areas according to Katheryn Hayes Tucker, *Daily Report*, (January 15, 2015). The Board of Governors approved the proposal by a two-one margin.

The second item, which generated heated discussion, and was approved by the Board of Governors, concerned the topic of increasing judicial salaries as well as those of District Attorneys and Pubic Defenders. Board of Governor Randy Evans, counsel to Governor Nathan Deal, warned that coupling the salaries of District Attorneys with Public Defenders with increases for the judiciary would make any future pay increases for judges more difficult for legislators to approve. President Perkins-Hooker dismissed that concern and indicated that the Bar was proposing three separate bills not one bill tying all three pay increases together.

I called Rep. Craig Gordon, Rep. Mickey Stephens and Sen. Lester Jackson, DDS, in order to follow up on what they have heard about judicial pay raises. Sen. Lester Jackson expressed that he had "strong concerns" about approving judicial salaries because of the cost factor. Rep. Mickey Stephens and Rep. Craig Gordon were also concerned about the costs and where the money would come from to pay for the increases. They had not heard that the Bar was also planning to lobby for increased pay for District Attorneys and Public Defenders. It would appear that Randy Evans' concerns have merit: it is going to be a tough vote just to get the judicial salary increases; lobbying for additional legislation increasing the salaries of the District Attorneys and Public Defenders may not be prudent at this time.
