#### **COURT OF APPEALS NEWS**

On January 5, 2011, Judge John J. Ellington was sworn in as the 25th Chief Judge of the Court of the Court of Appeals of Georgia. Judge Ellington has been on the court since 1999, when he was appointed by former Governor Roy Barnes.

On January 6, 2011, Christopher J. McFadden was also sworn in as a judge for the Court of Appeals of Georgia.

Do you have arguments scheduled before the Court of Appeals? If your arguments are scheduled during the legislative session, please be aware that parking will be considerably more difficult!

The Court of Appeals will have furlough days on Friday, January 14, 2011 and Friday, February 18, 2011. Please bear this in mind when considering your filing deadlines.

#### SUPREME COURT ANNOUNCEMENTS

Effective January 31, 2011, please be advised that a Certificate of Good Standing will cost **\$10.00**.

At this time, it appears that the price increase only applies to the Supreme Court of Georgia. Although there is no indication that the Court of Appeals certificate is going up in price, it might be beneficial check with the Court before making any requests.

# NEW GENERAL ORDER IN THE U.S. BANKRUPTCY COURT FOR THE SOUTHERN DISTRICT OF GEORGIA

On December 22, 2010, General Order No. 2010-3 was signed into effect in the United States Bankruptcy Court for the Southern District of Georgia. A copy of the order is available on the Bankruptcy Court's website, www.gasb.uscourts.gov. Pursuant to this General Order, the Court has reviewed the relevant factors supporting fees awards in Chapter 13 cases. Based on the evidence, the Court vacated General Order 2007-6 and made the following determination:

Effective in all Chapter 13 cases filed on or after January 1, 2011, a claim for attorney's fees for services rendered and expenses advanced to a Chapter 13 debtor will be deemed automatically approved by the Court, in the absence of an objection, so long as said claim does not exceed the sum of three thousand dollars (\$3,000.00). <u>The \$3,000.00 fee contemplates appearance by counsel of record for the debtor at the sec. 341 meeting and all hearings</u>.... In the event a debtor's attorney subsequently determines that an award of \$3,000.00 does not adequately compensate the attorney for legal services rendered, the attorney may petition for reasonable attorney's fees....
