Chatham County Juvenile Court's Family Dependency Treatment Court Receives National Honor

Chatham County Juvenile Court's Family Dependency Treatment Court has again been honored with maintaining its status of National Peer Learning Court after having been first selected as one in 2012 by the Office of Juvenile Justice and Delinquency Prevention (OJJDP) and the national child welfare organization, Children and Family Futures. The Family Dependency Treatment Court program is designed to break the cycle of addiction and neglect through monitored service delivery and ongoing and expedited permanency planning. The primary mission of the Family Dependency Treatment Court is to improve the lives of children and their families by addressing the deprivation resulting from the substance abuse of a parent or care giver.

As a National Peer Learning Court, the Chatham County Family Dependency Treatment Court mentors developing courts by sharing information and giving other teams an opportunity to travel to Chatham County to observe Family Dependency Treatment Court staffing and sessions. The Family Dependency Treatment Court has hosted several courts from along the east coast and was represented at national conferences in both California and Washington, D.C. The Family Dependency Treatment Court is excited to continue its partnership with OJJDP and Children and Family Futures and looks forward to providing technical assistance to courts across the country.

State Bar of Georgia Board of Governors Report

The Board of Governors for the State Bar of Georgia held its fall meeting on Saturday, November 1, 2014 at the Jekyll Island Club on Jekyll Island, Georgia. The meeting was called to order by the President of the State Bar, Patrise Perkins-Hooker. The first order of business was to approve the amended consent agenda, which included the appointment of **Lester Johnson**, **III** of Savannah and Lester Tate of Carterville, Georgia as State Bar representatives to the Judicial Qualifications Commission. Lester Johnson fills the seat formerly held by former State Bar President Robert Ingram and gives a member of the Savannah Bar Association a seat on this very important state commission.

Next the Board of Governors took up several action items proposed by the Advisory Committee for Legislation ("ACL") relating to the upcoming legislative session in January. The first legislative proposal was presented by the Family Law Section of the State Bar to amend O.C.G.A. § 19-3-62(a) to require that antenuptial agreements be attested and notarized by at least two witnesses. After very little comment, the Board of Governors unanimously approved supporting the legislation.

The Real Property Law Section presented proposed legislation to provide for a private cause of action for the unauthorized practice of law in residential real estate closings, the preparation of legal documents, and assistance with immigration matters. The proposed change to state law has been studied by the Real Property Law Section for more than two years and stems from complaints brought to the State Bar's attention in recent years over witness only real estate closings and the increase in legal form document companies entering the marketplace. It is anticipated that non-attorney settlement companies, title insurance underwriters and legal form document companies such as "LegalZoom" will likely oppose the State Bar's efforts in passage of this law. The Board of Governor's unanimously approved supporting this proposed legislation.

The last action items brought by the ACL to the Board were two funding requests for the 2016 fiscal year that the State Bar has supported in the past: 1) providing state appropriations for legal services to assist low-income victims of domestic violence and state appropriations for the Georgia Appellate Practice; and 2) Educational Resource Center to represent indigent death sentence prisoners in habeas corpus proceedings. Support for both funding requests was unanimously approved.

During the President's report, Patrise Perkins-Hooker gave an overview of her first four months in office. In addition to focusing on diversity inside the State Bar, she has been working with Bar leaders and Georgia law schools to encourage lawyers to practice in the rural areas of the state. Similar to what is taking place in the medical community, President Perkins-Hooker would like to see assistance given to rural lawyers to offset rent, utilities, and other expenses to attract lawyers to underserved areas of the state. She also reported that new technology has been installed in the Savannah and Tifton offices to improve communication with the Atlanta office to make meetings and CLE programs between the offices easier for participants. Looking ahead to the remainder of her year as President, she plans on focusing on communications and efforts with the media to promote the State Bar and its lawyers. She is working on an incubator program with Georgia law schools for recent law school graduates and she is planning a celebration and symposium for March of 2015 to celebrate the 800th anniversary of the signing of the Magna Carta.

In other informational reports, Sharri Edenfield, current President of the Young Lawyers Division ("YLD") reported that YLD is spearheading a military support initiative to aid Georgia's veterans through legal clinics, the handling of veteran's affairs appeals, and supporting YLD members serving in the JAG Corps. **Quentin Marlin** of Savannah has been appointed as a Director of Military Support for the YLD to aid in this endeavor. Sharri also reported that the upcoming YLD signature fundraiser scheduled to be held in early 2015 will benefit the August Warrior Project, an advocacy 501(c)(3) charity based out of Augusta which supports military veterans in thirteen Georgia counties.

There were two special presentations made during the meeting. The first was a resolution honoring **Harvey Weitz**'s service to the State Bar. As many of you know, Harvey was a long time member of the Board of Governors and a member of the Executive Committee for ten years. Harvey's brother, Julian, was present at the meeting and accepted the resolution on behalf of the Weitz family. Secondly, the State Bar recognized Randy Davis, a member of the Board from Cartersville, who was the pilot of the Gulfstream aircraft that flew one of the doctors infected with Ebola back to the U.S. from Liberia. In addition to the resolution recognizing Randy, the State Bar honored Randy with a glass blown statute of a Gulfstream jet being guided through the air on the wings of angels.

To conclude the meeting Chip Trefrey with Member Benefits, Inc., the State Bar's recommended broker for health insurance, gave an overview of the private insurance exchange offered through the State Bar. For more information on the health exchange, please visit, www.gabar.memberbenefits.com.

The winter meeting of the Board of Governors will be held in conjunction with the State Bar midyear meeting, January 8-10, 2015 in Atlanta at the Marriott Marquis hotel.

Thank you for allowing me to serve you as a member of the State Bar of Georgia Board of

Governors for the Eastern Circuit. The other members of the Board of Governors from the Eastern Circuit are **Lester B. Johnson, III** (Law Firm of Lester B. Johnson, III, P.C.), **Gwendolyn Fortson Waring** (The Waring Law Firm), who was appointed by the State Bar President to fill the unexpired term of Harvey Weitz, and **Sally Akin** (Ellis Painter). In addition, your representation from Savannah includes **Patrick O'Connor** who is the current Secretary of the State Bar of Georgia and serves as a member of the Executive Committee.
