In Other Legal News....

On June 4, 2010, the Standing Committee on the Unlicensed Practice of Law issued Advisory Opinion No. 2010-1 which provided, in part, as follows:

QUESTION PRESENTED

Assuming no traverse has been filed by any party in a garnishment action, is the completion, execution and filing of an answer in the garnishment action by a non-attorney employee of the garnishee considered the unlicensed practice of law? <u>SUMMARY ANSWER</u>

A nonlawyer who answers for a garnishee other than himself in a legal proceeding pending with a Georgia court of record is engaged in the unlicensed practice of law.

On September 12, 2011, the Supreme Court of Georgia issued a decision without an opinion approving UPL Advisory Opinion No. 2010–1 pursuant to State Bar Rule 14–9.1(g)(4). (A concurrence by Justice Nahmias is available at 2011 Ga. Lexis 654.) As it now stands, a non-lawyer, such as an employee of a corporation, who answers for a garnishee in a legal proceeding in a Georgia court of record is engaged in the unlicensed practice of law. At least one state lawmaker, House Judiciary Committee Chairman Wendall Willard, intends to introduce a bill in the upcoming legislative session to allow non-attorneys to file answers on behalf of their companies.

Fee Changes In Federal Court

Please be advised that a new miscellaneous fee schedule is available on the website for the U.S. District Court for the Southern District of Georgia at <u>www.gasd.uscourts.gov</u>. A few costs, including fees for document filing, misdemeanor appeals, attorney admissions and others have been increased. The new fee schedule became effective on November 1, 2011.
