Gearing-up for the Sixth Annual Legal Food Frenzy

2017 marks the 6th year of a most successful partnership between the Georgia Food Bank Association, the Office of the Attorney General and the State Bar of Georgia Young Lawyers Division of hosting

the statewide competition, Georgia Legal Food Frenzy. The Legal Food Frenzy, a friendly competition within the legal community to gather food and funds, will run April 17-28, 2017, with registration opening March 1.

The first five years of competition brought in over 5 million pounds of food for the eight regional food banks in the state. America's Second Harvest of Coastal Georgia depends on the additional pounds of food and money as we prepare for Summer Feeding and the significant increase in food insecure children during those months. There are nearly 57,000 children in our 21 county service area that experience food insecurity. Food insecurity is particularly devastating to children. According to the National Scientific Council on

Developing Children, "the foundation for cognitive functioning is laid in early childhood. This foundation can be greatly compromised by food insecurity. Inadequate nutrition can permanently alter a child's brain architecture and stunt their intellectual capacity affecting their ability to learn, function in a social capacity or be productive."

12th Annual Leadership Institute Conference Presents Leadership and Development Strategies for Women of Color Attorneys in Firms, Corporate Law Departments, and the Public Sector

Women attorneys from across the country will attend this year's 12th Annual Conference of the Leadership Institute for Women of Color Attorneys on March 22-23, 2017, at the Ritz-Carlton, Atlanta (Downtown).

The Conference will address a range of topics relevant to women of color attorneys as lawyers, as women, as mi-



norities, and as professionals practicing law in an increasingly competitive and often homogenous environment. The 2017 conference will focus on technology as a growth industry for women of color and address specific strategies aimed to increase opportunities for visibility and leadership, within their organizations.

A group of expert panelists and workshop facilitators from all over the country, will share their invaluable expertise and inspiring biographies of trials and tribulations. It promises to be an excellent opportunity for networking and mentoring in a welcoming and collegial environment.

The Conference begins on March 22, 2017, with the Georgia-Pacific and Nelson Mullins Networking Reception, with speaker Aisha Christian, Founder of Bigtooth Ventures and former General Counsel of Rent the Runway.
