Supreme Court of Georgia to Hold Oral Arguments at Savannah Law School

The Supreme Court of Georgia will hold oral arguments at Savannah Law School on Thursday, April 14 at 2:00 p.m. Court will be held in the 4th-floor courtroom of the new law school, which graduated its first class of law students last year and is located at 516 Drayton Street in Savannah.

The court will hear appeals in two cases – one criminal and one civil. In the first case, state prosecutors are appealing a Georgia Court of Appeals ruling that upheld a Bryan County superior court's decision transferring to juvenile court the case of a 16-year-old who was arrested for aggravated sexual battery. The appeal in the second case stems from a dispute between the Chatham County Board of Commissioners and the Clerk of Superior Court over whether in addition to state cost of living increases; the court clerk is also entitled to local cost of living increases.

Following oral arguments, Savannah Law School invites all attendees to join them at a 5:00 p.m. building dedication ceremony and reception celebrating the recent facility renovations.

As always, media are welcome. Due to limited capacity, any media planning to attend – print or broadcast – should complete and submit by April 12 the media request form located on the court's website: www.gasupreme.us. Depending on how many are received, photographers and television stations may need to work out a pool among themselves. Also, please familiarize yourself beforehand with the court's Media Rules, which are also located on their website.
