Savannah Lawyer and Law Student Honored by State Bar The State Bar of Georgia honored five advocates at its annual pro bono awards reception held Oct. 15 at the State Bar headquarters in Atlanta. Of the five honored, two were from Savannah, Dolly Chisholm and Meagan Rafferty.

Dolly Chisholm was presented the H. Sol Clark Award for her lengthy

pro bono service record and for her role in the Georgia Legal Services Program Foundation. She was nominated for the Award by Bill Broker, Managing Attorney at Georgia Legal Services, for her work with the Pro Bono Project. Her law firm, Bouhan+Falligant LLP, received



praise for its support of Chisholm's work and for its pro bono service in the Savannah community. The award is named for former Georgia Court of Appeals Judge H. Sol Clark of Savannah, who is known as the "father of legal aid in Georgia." The prestigious award honors an individual lawyer who has excelled in one or more of a variety of activities that extend civil legal services to the poor.

The Law School Excellence in Access to Justice Individual Award was presented to Meagan M. Rafferty for the access to justice activities she undertook as a student at the Savannah Law School. Associate Professor Andrew Wright praised Rafferty for her academic performance and the variety of ways she contributed to increasing access to justice through public interest law. In addition to her other activities, Rafferty was hosted by Georgia Legal Services (Savannah) for an internship.

The Law School Excellence in Access to Justice Award specifically recognizes a law student who has excelled in participation in support of a civil pro bono or legal aid program or who has developed or has been instrumental in the development of a civil pro bono program satisfying previously unmet civil legal needs or extended services to underserved segments of the population.

## **Submission of Proposed Orders to Superior and State Courts**

The Bench and Bar Committee continues to work with the Chatham Superior and State Court Judges and Administrators to seek ways to expedite rulings on motions that have been fully briefed and argued.

The committee previously announced that the **Superior Court Judges** will accept Proposed Orders through e-mails sent to their administrative assistants but **not** to their staff attorneys. The e-mail should request that the administrative assistant forward the Proposed Order to the attention of the staff attorney working on the case.

The **State Court Judges** have recently authorized the committee to announce that they will also accept Proposed Orders, which should also be sent via e-mail. However, the State Court Judges have instructed that the Proposed Orders be sent to **both** the Judge's administrative assistant and the civil or criminal staff attorney, depending on the type of case.

The State Court Judges have also established a "dashboard" website connection that attorneys can use to request the status of a pending motion through the office of the Court Administrator. This inquiry will anonymous, unless the attorney provides identifying information (see details below).

The specific instructions for submitting a Proposed Order to a particular Judge are set forth below for each Judge, including the specific e-mail addresses that should be used. As with all correspondence to a judge or a judge's office, all counsel of record should be copied on the email that is used to transmit a Proposed Order.

In addition, in preparing a Proposed Order, the Judges have indicated that each statement of fact recited in a Proposed Order needs to have an accurate and specific record citation, and where legal principles are stated in a Proposed Order, appropriate citations to statutes and case precedents should follow. Litigants are not required to submit Proposed Orders, and the Proposed Orders should not simply constitute a regurgitated argument from a submitting party's briefs. A Proposed Order should represent the party's commitment to the Court that, if entered, it is the best work product that the party can submit for purposes of accurately stating the facts of record and the applicable law and successfully sustaining review by an appellate court.

## **Submission of Proposed Orders to Superior and State Courts**

Instructions for submitting Proposed Orders to Superior Court Judges:

The Superior Court Judges agree that it would be of assistance to the court and may help expedite rulings if Proposed Orders accompany the motions and responses thereto, either at the time of filing or immediately after oral argument, if scheduled. The Proposed Orders should be sent via email, in an editable format such as Word or Word Perfect, to the judge's administrative assistant, with a notation that the correspondence should be directed to the attention of the staff attorney. The Proposed Orders should be sent to the applicable judge's administrative assistant via e-mail at the following addresses:

The State Courts Judges have asked The Bench and Bar Committee of the Savannah Bar Association to let all bar members know that, in some instances, it may be of assistance to the court if proposed orders accompany the motions and responses thereto, either at the time of filing or immediately after oral argument, if scheduled. In addition to including copies for the Clerk to "furnish" to the Judge as required by Rule 6.1, electronic copies of proposed orders may be emailed to the judge's administrative assistant and staff attorney in a single email as an editable format such as Word or Word Perfect.

## **State Bar Board of Governors Report**

The Board of Governors for the State Bar of Georgia held its fall meeting on Saturday, October 24, 2015 at the Hyatt Hotel in Savannah.

In early October, the President-Elect of the State Bar of Georgia, Rita Sheffey, unexpectedly resigned her position. After reviewing the State Bar's by-laws and

consulting with Bar counsel, the current President of the State Bar, Bob Kauffman, appointed Pat O'Connor to serve as President-Elect and also continue to serve as Treasurer. During the Board of Governor's meeting in Savannah, Bob Kauffman asked for the Board of Governors to ratify his decision. After O'Connor was properly nominated and nominations were closed, the Board of Governors unanimously approved O'Connor as President-Elect. Immediately after the vote, Presiding



Justice Harris Hines swore in O'Connor to serve as President-Elect for the remainder of the 2015-16 bar year.

In other action items, Bill NeSmith, deputy general counsel, presented several rules changes and bylaws amendments to the Board of Governors. The rules for the Lawyer Assistance Program (LAP) were amended to allow the committee to appoint a network of peer-support volunteers. These volunteers will be able to provide support to impaired or potentially impaired attorneys by sharing life experiences for mental/emotionally health problems or substance abuse problems. Rule 1-501 was clarified to require that costs, charges and penalties assessed by the State Bar as the result of a cancelled or dishonored payment will put a member's good standing status in jeopardy similar to a failure to pay dues. Finally, changes were approved to the nominations and elections bylaws to clarify voter lists, distribution of ballots, and the methods for a recount in State Bar elections.

The Board of Governors next heard presentations from Elena Kaplan, Vice-Chair of the Advisory Committee for Legislation (ACL), and Rusty Sewell, lobbyist for the State Bar, regarding certain State Bar positions on upcoming legislation. The Board again approved the funding request for the legal representation for victims of domestic violence and approved a policy to support pay parity for assistant public defenders and assistant district attorneys. ACL also recommended the Board of Governors support the passage of Senate Bill 64 introduced during last years' legislative session. In 2008, the General Assembly created a method of administrative legitimation by the execution of a voluntary acknowledgment in order to parallel the ability of biological parents to execute a voluntary acknowledgment of paternity. Since the passage of the law, it has created many unintended consequences of equating these two concepts and eliminating judicial oversight as to the best interest of the child.

## State Bar Board of Governors Report Cont'd

SB 64 would repeal certain of these unintended consequences. The legislation is supported by the family law section of the Bar and several other lawyer and judicial councils who practice in the area of family law.

In other business, the Board of Governors unanimously approved the re-appointment of Jenny Jenson and the new appointment of Virgil Adams as the State Bar's representatives to the Commission on Continuing Lawyer Competency (CCLC).

Having completed the action items on the agenda, information reports were made by the President of the Bar, Treasurer, and the YLD President. A special report was given by Michael Ethridge regarding the South Carolina Bar's Attorney Wellness Committee and how it is being used as a model for Georgia in developing our own wellness initiative. John Haubenreich, Chair of the Disciplinary Rules and Procedure Committee gave a special report on the meetings his committee has been having in reviewing the State Bar's current disciplinary process and making proposed changes to the Board of Governors before the end of the current bar year.

Finally, Susan Cox gave an overview of the Ogeechee Circuit, and our very own John Manly gave a report on the activities on State Bar members in the Eastern Circuit.

After the Board of Governor meeting was adjourned, a "strategic planning session" was held to review the work done by the executive committee and a third party consultant, Leadership Strategies, who has been developing a 2016-2018 Strategic Plan for the State Bar. After a detailed presentation on the plan, Board of Governors members gave comments to the plan through a break-out session and through written comments. Leadership Strategies will report back to the Board of Governors during the midyear meeting in January for a final presentation of the strategic plan.

The midyear meeting of the Board of Governors will be held January 7-9, 2016 at Legacy Lodge at Lake Lanier Islands in Buford, Georgia.

Thank you for allowing me to serve you as a member of the State Bar of Georgia Board of Governors for the Eastern Circuit. The other members of the Board of Governors from the Eastern Circuit are Sally Akins, Lester Johnson, III, and John Manley. In these roles Pat also serves as a member of the Executive Committee.



You must include your GA Bar Number to complete your registration. The Chatham County Information and Communication Systems (ICS) Department oversees this process. If you have any problems, contact the ICS Department at 912 652-7343.

The State Court Motion Status Request feature allows attorney to direct questions to the presiding Judge and staff about the status of a specific motion or motions by completing the following on-line form. (Your view of the webpage many look slightly different but the form will be the same.)



The presiding Judge and staff will receive the correspondence and will reply to all parties. Some attorneys have asked that they be able to send the request anonymously. With this in mind, the email received by the Judge and staff does not include the e-mail address of the sender. If you wish to identify yourself, you may include this information in the text box reserved for the style of the case.
