Local Attorneys Honored for Community Impact at February Pro Bono Awards Luncheon

Four attorneys were recognized for their outstanding pro bono contributions to the Greater Savannah Region on Thursday February 15, 2024, at the 2023 Pro Bono Awards, presented by the Savannah Bar Association (SBA), in partnership with Georgia Legal Services Program (GLSP).

Pro bono service – when attorneys take on legal matters without the expectation of being paid – is one of the most impactful ways that attorneys choose to give back to their communities and meet their ethical obligations. In 2023, of the 1,500 cases accepted by GLSP's Savannah office, nearly 170 were handled on a pro bono basis by 40 area attorneys with a commitment to service.

The honorees at this year's Pro Bono Awards exemplify that personal connection.

Two attorneys tied for the *Pro Bono Champion Award* for handling the most pro bono cases in 2023: Anthony Burton and Jerold Murray.

Anthony Burton, Burton Law Offices, handled 17 pro bono cases last year, representing clients seeking protective orders in domestic violence situations. This is the second year in a row, Mr. Burton has received the *Pro Bono Champion Award*.

Jerold Murray, Law Office of Jerold L. Murray, LLC, also handled 17 pro bono cases last year, representing clients seeking protective orders in domestic violence situations. Mr. Murray has volunteered for GLSP for 10 years and has handled nearly 150 pro bono cases. He received the *Pro Bono Champion Award* in 2016 and the *Pro Bono Advocate Award* in 2015.

Steven Woodward is the recipient of the Pro Bono Advocate Award for exceptional service to the underserved in the Savannah area. Mr. Woodward, a solo practitioner, represented a client in a security deposit case. Mr. Woodward successfully obtained a default judgment for his client against an absentee landlord. He stayed on the case for another year to assist the client in collecting the judgment.

Dolly Chisholm is the recipient of the *Pro Bono Service Award*. For over 20 years, Ms. Chisholm, a partner at Bouhan



Falligant LLP, has assisted GLSP clients with wills, powers of attorney, and advanced directives for healthcare. She received the *H. Sol Clark Pro Bono Award* from the State Bar of Georgia in 2015.

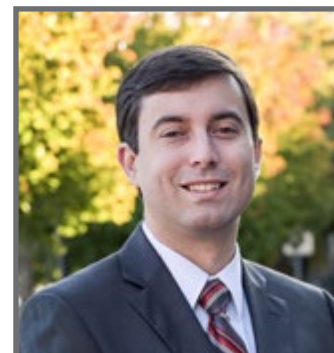

The Georgia Super Lawyer recognition is awarded annually to the top five percent of attorneys in the state. The honor is based on independent research, peer review, and professional achievement.

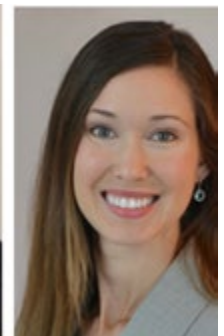
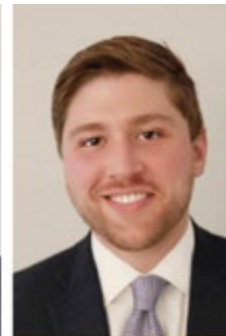

The new partnership will provide for an increase in on-the-ground action in Savannah ensuring complaints are being met with proper response and citizens are not being taken advantage of by housing practices.

“We are excited about these new partnerships as we strengthen our existing services to Savannah residents,” Director of Human Services Kerri Reid said. “We encourage residents to reach out through these new resources if they feel they have been discriminated against. We are here to help.”

Trainings and Resources

Georgia Appleseed provides virtual and in-person trainings and develops and distributes written resources to give advocates the information and confidence necessary to stand up for children. To request a training, please contact fair@gaappleseed.org.

School Tribunal Referrals

Georgia Appleseed provides additional support for students who are facing removal from school for a period of more than ten days. In these cases, students are entitled to a school disciplinary hearing (often called a "tribunal"), which can be an overwhelming experience for the child and DFCS representatives. If you have a child in foster care who is facing a school disciplinary hearing, please fill out our referral form at www.ReferralGAA.org to receive support and guidance.

Community Advocacy Support

After we receive your referral, Georgia Appleseed will link you with an advocate who will provide Community Advocacy Support (CAS). Through CAS, you will get step-by-step guidance on what to expect in the tribunal process, and how to strategize and prepare for the child's case. For CAS to be effective, it is critical that you remain involved and responsive to the advocate providing support.

Direct Legal Representation

In some cases, Georgia Appleseed matches the child with an attorney who will represent the child at the tribunal. The attorney will contact you to schedule the intake process and a meeting with the child. To effectively represent the child, the attorney relies on your knowledge of the child's case and your expertise. Please remain involved and responsive to the attorney.
