State Representative Derek Mallow Presents The Outstanding Georgia Business Award To Oliver Maner During The Firm's 125th Anniversary Year

FREE CLE Opportunities

On August 10, 2022 from 1 pm – 4 pm, the Chatham County Child Advocate Office will host a free continuing legal education opportunity. Diana Rugh Johnson, and Jerry Bruce will be on hand to present **Drug Testing in Child Welfare Cases: Labs, Laws, and Litigation**.

Ms. Johnson is the Director of the Court Improvement Project, with the Supreme Court of Georgia's Committee on Justice for Children. Mr. Bruce is the Director of the Georgia Office of the Child Advocate. Both have substantial experience in child welfare matters.

The presentation will discuss the important role of drugs tests in child welfare litigation. Drug tests inform important decisions in dependency courts from removal to termination of rights, but for test results to be truly useful, they must be understood, admitted into evidence and weighed appropriately. This session will educate participants in the science of drug testing, evidentiary rules that affect the admissibility of results, and the trial skills necessary for effective presentation and argument to the court.

The 12th Annual Red Mass will be held in St. Mary's Chapel at the Pastoral Center, 2170 E. Victory Drive, Friday, September 30, at noon. A reception will follow in Boland Hall.

The Red Mass is celebrated annually in the Catholic Church for judges, lawyers, law school professors, law students, and government officials. The Mass requests the guidance of the Holy Spirit for all who seek justice, and offers the opportunity to reflect on what Catholics believe is the God-given power and responsibility of all in the legal profession. It is also an opportunity to remember the attorneys who have passed away since the last celebration in 2019.

Originating in Paris in 1215, the Mass is called the "Red" Mass referring to the color of the vestments worn. Red is chosen to symbolize the tongues of fire (the Holy Spirit) that descended on the 12 Apostles on Pentecost (Acts 2:1-4).
