
A NOTE FROM JUDGE TOM BORDEAUX

Defense of Sexual Assault in the Armed Forces

Keith Harrison, Associate Dean of the Savannah Law School, was recently appointed by the Secretary of Defense to serve on the Defense Advisory Committee on Investigation, Prosecution, and Defense of Sexual Assault in the Armed Forces (the "Committee").

The Committee was established by the Secretary of Defense in February 2016 as required by Section 546 of the National Defense Authorization Act for Fiscal Year 2015 and Section 537 of the National Defense Authorization Act for Fiscal Year 2016. The Committee advises the Secretary of Defense on the investigation, prosecution, and defense of allegations of rape, forcible sodomy, sexual assault, and other sexual misconduct involving members of the Armed Forces based on its ongoing review of such cases.

The Committee held its first public meeting on January 19, 2017, in Arlington, Virginia. At this meeting, the Committee received informational presentations on the court-martial process, recent legislation involving sexual assault in the U.S. military, and the results of two predecessor Department of Defense advisory committees on sexual assault.

The Committee meets quarterly and is developing a strategic plan for review and assessment of sexual misconduct in the Armed Forces. The Committee must issue annual reports detailing its activities from the preceding year. The Committee's initial report will be released by March 30, 2017.
