#### About the Judge Eugene H. Gadsden Scholarship:

The Judge Eugene H. Gadsden Memorial Scholarship was established by the Savannah Bar Association in tribute to the memory and legacy of Judge Gadsden as an outstanding community leader known for his character, integrity and compassion. His fairness, patience, and wisdom served as an inspiration not only to all lawyers and judges but also the community at large. The purpose of the scholarship is to assist a graduating senior from a high school in Savannah in attending an accredited college or university. The award is based on merit, and it provides an annual amount of \$1,000 for four years. The award may be used for tuition and fees, books, and other academic expenses. All applicants who have applied for or will be receiving other financial support must reveal that information and include it with the application. Applicants must meet entrance requirements of the institution and maintain grades in keeping with the standards of the Hope Scholarship. Applications for the Judge Eugene H. Gadsden Scholarship must be obtained from the high school's guidance counselor.

The fairness, patience, and wisdom of Judge Kravitch served as an inspiration not only to all lawyers and judges but also the community at large. The purpose of this scholarship is to assist a rising second or third-year law school student from Chatham County in continuing his/her education at an accredited school of law. The scholarship award of \$2,500 is given to one student based on merit for the second or third year of study in law school. A second-year law student who receives an award may apply for an additional award for his/her third year. The award granted may be used for

tuition and fees, books, and other academic expenses. All applicants who have applied for or will be receiving other financial support must reveal that information with the application. # Tenth Annual Legal Food Frenzy

Friends and colleagues,

The 10th Annual Legal Food Frenzy begins April 19! Last year, Savannah lawyers helped raise \$27,836.50 for our local food bank, America's Second Harvest of Coastal Georgia. This year, we want to surpass that number.

There is an enormous need for monetary donations during this trying time as the Second Harvest responds to a sustained 50 percent increase in food assistance as a result of the COVID-19 pandemic. Many families who have typically been food secure were impacted by the economic effects of the pandemic and are reaching out to the food bank for help for the first time. Families who were already struggling to put food on the table have been coping with increased hardship. Additionally, many students in Chatham County were learning remotely until very recently and were unable to receive the free or reduced-priced lunch they typically get at school. For every \$1 donated during the Legal Food Frenzy, Second Harvest can distribute roughly four meals into the community.

# Bouhan Falligant's Appellate Practice Helps Victims of Family Violence

Bouhan Falligant's appellate practice was honored to file a pro bono brief on behalf of a victim of family violence on Monday, asking the Court of Appeals to honor the plain-text meaning of a Georgia law allowing family-violence victims to seek protective orders against their alleged abusers. Lucas Bradley, a partner with the firm's appellate practice, had primary responsibility for the brief and was assisted by Logan Lineberry, an associate in the practice group.

Georgia Legal Services brought the matter to Bouhan Falligant's attention as part of its broad-based work on behalf of victims of family violence. As Vicky Kimbrell, Director of the GLSP Family Violence Project, noted, its services are all the more important during the COVID-19 pandemic. Kimbrell stated that "the stress, the danger, the losses of income and resources has led to a 46% increase in crisis calls to Domestic Violence programs. Survivors are turning to the courts for the safety they need during this time, and they need our support."

Bouhan Falligant has a robust pro bono appellate practice, and its work in this case follows its two appellate wins last year on behalf of a historical African-American church in a dispute involving that church's property rights. "Appellate practice is where the rubber hits the road—not just for individual cases, but vindicating the rights of all future litigants relying on Georgia precedent," said Lucas Bradley. "We are honored to lend the firm's resources and expertise to members of our community who need help navigating Georgia's appellate courts."


#### Southeastern Georgia Chapter of the American Board of Trial Advocates Announces New Slate of Officers



#### The Need for Legal Representation with TPOs Increases

When the pandemic began a little over a year ago, it was feared that the self-isolation, social distancing, and shelter-in-place orders would increase instances of domestic violence. Unfortunately, those fears have come true.

"The stress, the danger, the losses of income and resources has led to a 46% increase in crisis calls to Domestic Violence programs. Survivors are turning to the courts for the safety they need during this time." says Vicky Kimbrell, Director of the GLSP Family Violence Project.

Although we are all glad to see the threat of the pandemic lifting, we expect more survivors will now be able to escape those violent homes. Those survivors will need legal representation.

GLSP-Savannah receives referrals from SAFE Shelter and the Family Justice Center. SAFE Shelter's Outreach Program arranges legal representation for all their TPO clients. If a pro bono attorney cannot be secured, the shelter pays for legal assistance.

In 2020, SAFE Shelter referred 109 cases to GLSP-Savannah. Twenty-one pro bono attorneys represented 58 clients at their 12-month hearings, saving the shelter nearly \$30,000 in attorney's fees. Unfortunately, 41 clients were referred back to the shelter because there was not an available pro bono attorney to represent them.

Now is a great time to become a pro bono attorney. TPO Petitioners need legal representation at 12-month hearings. We provide training, support, and malpractice insurance for cases you handle for us.
