

### Three Local Attorneys Honored for Community Impact at Annual Pro Bono Awards Luncheon

Sarah Anderson, Supervising Pro Bono Attorney at Georgia Legal Services Program, Highlights Personal Connections of Pro Bono Service in Remarks

Three local attorneys were recognized for their outstanding pro bono contributions to the Greater Savannah Region on Thursday, March 23, at the 2022 Pro Bono Awards, presented by the Savannah Bar Association, in partnership with Georgia Legal Services Program (GLSP). Speaking at the event was Sarah Anderson, Supervising Attorney in GLSP's Pro Bono Program and staff member in the organization's Savannah office.

Pro bono service – when attorneys take on legal matters without the expectation of being paid – is one of the most impactful ways that attorneys choose to give back to their communities and meet their ethical obligations. In 2022, of the 1,100 cases accepted by GLSP's Savannah office, nearly 170 were handled on a pro bono basis by 31 area attorneys with a commitment to service.

The honorees at this year's Pro Bono Awards exemplify that personal connection.

Anthony Burton, recipient of the Pro Bono Champion Award, handled the highest number of pro bono cases in 2022. Mr. Burton, who works for the Burton Law Offices, handled 26 pro bono cases last year, representing clients seeking protective orders in domestic violence situations.

Mr. Burton, a former prosecutor with the Chatham County District Attorney's Office, has always had a passion for helping victims of crime, especially those who suffer from domestic violence. "I greatly appreciate GLSP for allowing me to continue to serve victims of crime in private practice by working with GLSP and SAFE Shelter to help secure TPOs for survivors of domestic violence."

**Benjamin C. Davidson** is the recipient of the Pro Bono Advocate Award for exceptional service to the underserved in the Savannah area. Davidson, an associate with The Cornwell Firm, represented a domestic violence survivor at her 12-month hearing. Shortly after the Court granted the order, the respondent came to the client's home with a gun, shooting a bystander. While the county pursued a criminal action against the respondent, Mr. Davidson successfully pursued a contempt action to ensure the safety of his client and her family.

**Gwendolyn Fortson Waring**, recipient of the Pro Bono Service Award, was recognized for providing over 20 years of pro bono work for Georgia Legal Services Program and its clients. Since 1994, Fortson Waring, owner of The Waring Law Firm LLC, has practiced civil trial litigation in Savannah, concentrating in employment, family, and probate law. Her broad range of expertise has prepared her to answer the call for assistance whenever there is a need.

Guest Speaker Sarah Anderson Reflects on the Connection and Impact of Pro Bono Service

"Our volunteer attorneys take on pro bono cases not because of the promise of recognition, and it's not because they feel as if it's a forced obligation," explains Anderson. "They do it for reasons that are personal to them – that are meaningful to them. It may be that they have a personal experience they see reflected in the challenge that a client is facing; perhaps a friend, colleague, or loved one has walked that path. Or they may just want to ensure that one less person feels powerless and unseen in our justice system. Whatever their connection may be, their service has meaning to them – and powerful impacts for their client."

### In Memoriam: Bill Pinson

William H. "Bill" Pinson, Jr., born December 12, 1946 in Newnan, GA, died at Candler Hospital on March 20, 2023 in Savannah, GA, following an extended illness. He was 76-years-old and predeceased by his oldest daughter, Celia Pinson Iskandar.

A graduate of Mercer University, Bill graduated cum laude from Mercer's Walter F. George School of Law where he served as Georgia Survey Editor of The Mercer Law Review, a member of The Moot Court Team, and president of his legal fraternity. The year prior to his senior year in law school, Bill was selected to participate in an exchange student program (sponsored by the College of William and Mary) and spent the summer studying law at The University of Exeter Law School in Exeter, England. This experience was a highlight of his life,

as well as traveling throughout Europe with his wife Maxine during their time abroad. This experience provided the impetus for a lifetime of travel in other countries, as well as throughout the U.S., for Bill and Maxine.

Following graduation from law school, Bill and Maxine moved to Savannah in 1972, where Bill had a distinguished legal career specializing in civil litigation for forty years. During that time, he served as City Attorney and Recorder's Court Judge at Tybee Island, named to Who's Who in American Law and The Best Lawyers in America, selected as a Georgia "Super Lawyer," and he consistently received Martindale and Hubbell's top "AV" rating. In addition, Bill served as Chairman of the Savannah Bar Association's Ethics Committee, and he was a member of the Georgia State Bar's Professionalism Committee. Bill was a proud fellow of The American College of Trial Lawyers, The Georgia Defense Lawyer's Association. The Savannah Bar, The State Bar of Georgia, and a member of the Endowment Board of Historic Savannah Foundation. Bill was also a long-time member of The Oglethorpe Club in Savannah.

A man of a deep faith and strong Christian convictions, Bill was a student of the Bible and faithfully taught an adult Sunday School for almost forty-five years. He and Maxine became members of Skidaway Island's United Methodist Church, a few years ago, in order to worship with their daughter and grandchildren.

Bill Pinson was the quintessential Southern gentleman. In addition to being well-rounded and well-mannered, Bill was a gifted speaker. He was also a fervent reader and an engaging conversationalist with a rich sense of humor. Most of all, Bill enjoyed relaxing, laughing, and sharing special times with his family. After living in Savannah's Historic District for over fifty years, in a 19th century home they fully restored, Bill and Maxine had just moved into a quieter neighborhood when he became ill.

Bill is survived by Maxine, his wife of almost 55 years, his daughter Malyssa Pinson Ashbaugh, and two grandchildren: Ayele Pinson Ashbaugh and Celia Blair Ashbaugh. According to Bill's wishes, his graveside service will be a private one, and his cremains will be interred in Skidaway Island United Methodist Church's Memory Garden.
