## Bankruptcy Court Celebrates Constitution Day with Art & Essay Contest

In honor of Constitution Day (September 17), the United States Bankruptcy Court for the Southern District of Georgia held its annual art and essay contest for local elementary school students, who were asked to create a piece of art or write an essay about the freedoms set forth in the United States Constitution. Students from kindergarten through third grade submitted artwork, while fourth and fifth graders wrote essays. One winner was selected from each grade.

On November 6, the winning students were invited to the courthouse, where they were presented with pocket-sized guides to the Constitution, medals, and framed certificates. They also participated in a mock criminal trial before Chief Judge Edward J. Coleman, III, to illustrate important constitutional rights, such as the Sixth Amendment right to jury trial and the Confrontation Clause.

The winning entries are currently on display on the second floor of the Tomochichi Federal Courthouse.

## The Raccoon Sequel: Squirrels And Insurance Coverage

In the last issue of Coverage Opinions I mentioned the recent Pennsylvania federal decision in Capital Flip, LLC v. American Modern Select Insurance Company, No. 19-180 (W.D. Pa. Sept. 19, 2019), where the court held that no coverage was owed, under a property policy, for damage caused by raccoons that had entered the interior of a structure. The court concluded that coverage was barred as the damage was not caused by the covered peril of vandalism or malicious mischief: "Raccoons and their companions in the animal kingdom," the court concluded, "cannot formulate the intent needed to engage in 'vandalism,' 'malicious mischief' or any other criminal or actionable conduct. Animals do not have conscious agency and are not subjects of human law."

I was delighted to get a note from Coverage Opinions reader Arnold Young, of HunterMaclean in Savannah, Georgia, bringing to my attention a wonderful coverage decision from 1954 from the Court of Appeals of Georgia. It's not about raccoons – but squirrels. The court found that coverage was owed for damage to a playhouse caused by a squirrel. Why? Because the court had fuzzy feelings for the critter.

The decision is a gem. I'll get to that in a second. But that's just half the story. Arnold shared with me that the insured was represented by his former partner – Colonel E. Ormonde Hunter, who served in WWII and was part of the Office of Strategic Services, the predecessor to the CIA.

Hunter was quite a character, Arnold told me. An absolute gentleman, but tough. He was in the Georgia state legislature and served as vice-chairman of the Board of Regents of Georgia's state university system.

Known as a bon vivant, Hunter was married for the first and only time at age 65 and, according to Arnold, known around Savannah as "Hormone Hunter." As Arnold put it, "Only Colonel Hunter would provide a recipe for squirrel stew in an appellate brief." The Colonel died in 1989 at about age 95.

The court's decision in North British & Mercantile Insurance Company v. Mercer, 82 S.E.2d 41 (Ga. Ct. App. 1954), aff'd 84 S.E.2d 570 (Ga. 1954) speaks volumes about Colonel Hunter.

A squirrel descended the chimney of an insured's playhouse and damaged a maple table, chair, brass lamp, lampshades and sofa cushions. Coverage was sought under a policy that insured "all risks or loss of or damage to property" except "loss or damage caused by moth, vermin and inherent vice."

The insurer disclaimed coverage on the basis that a squirrel is vermin. Suit was filed and the jury returned a verdict for the plaintiff for the amount sued for -- \$179.50 -- plus \$50 attorney fees for bad faith.

The Georgia appeals court affirmed the verdict by agreeing with Colonel Hunter that squirrels have much to offer society:

"The brief of counsel for the defendant in error (which, incidentally, includes an excellent recipe for squirrel stew) concludes with the following words, with which this court is inclined to agree: "Vermin' is a mighty harsh word to hurl at our little friend the squirrel. He has long been well considered and much thought of as a pet and an attractive addition to the scenery of any city, garden, or country yard. He is praised in song and story as a shining example to mankind of industry and thrift. It is respectfully submitted that this court should not label the little fellow as nothing more that 'vermin."

## Georgia Legal Services Program Representation Yields HUD Approval of \$80,000 Settlement Resolving Fair Housing Act Allegations That Savannah Landlord Failed to Address Systematic Tenant-On-Tenant Racial Discrimination

In resolution of allegations of Fair Housing Act violations at The Woods of Savannah, Gene B. Glick Company, Inc., agreed to pay a total of \$80,000 and make systemic changes in the company's nondiscrimination policy, procedure, and trainings.

The Woods of Savannah is a project-based Section 8 housing complex for individuals 62+ years of age or disabled. Gene B. Glick Company, Inc., owns and manages The Woods of Savannah and Oglethorpe Square Apartments, A Limited Partnership, along with 100+ other low-income housing communities in the Southeast and the Midwest.

In early 2018, three single, disabled, African-American women approached the Savannah Regional Office of the Georgia Legal Services Program ("GLSP") for assistance with the living conditions at The Woods of Savannah.

White tenants started harassing the women the day each moved into the housing complex—before the other residents knew anything about the women other than the color of their skin. White residents used dogs to threaten the women and block their access to the housing complex's common areas. Among other forms of harassment, the women also endured racial slurs, physical threats, stalking, harassment at work, and being the subject of false reports to the police.

The women submitted dozens of complaints to the property's local and corporate management. In response, they were told the incidents were mere squabbles between neighbors and were warned to stop lodging complaints or they would face possible eviction. The women came to GLSP because they wanted the harassment to stop.

The Fair Housing Act protects against discrimination, in most private and public housing, based on a person's race, color, religion, sex, physical or mental impairment, familial status, or national origin. Under the Fair Housing Act, a landlord can be held liable for tenant-on-tenant race-based harassment when the landlord knew or should have known of the discriminatory conduct and the landlord failed to take prompt reasonable action to correct and stop the discriminatory conduct.

GLSP attorney Alison Slagowitz, Equal Justice Works Georgia Housing Corps Fellow, investigated and documented the harassment before drafting and submitting Fair Housing Act complaints for each client to the United States Department of Housing and Urban Development ("HUD").



Once HUD assigned a conciliator and investigator, Ms. Slagowitz provided HUD a detailed investigation report, timelines of major incidents of harassment, documentary evidence, and a legal memo supporting assigning liability to the housing provider for the tenant-on-tenant race-based harassment at The Woods of Savannah.

The parties reached a settlement through HUD's conciliation process that provided both individual relief to GLSP's three clients and systemic relief to ensure any future complaints of racial harassment would be properly addressed by Gene B. Glick Company, Inc. Each of GLSP's three clients received \$20,000. Further, Gene B. Glick Company, Inc., must create a \$20,000 compensation fund for current and prior residents of The Woods of Savannah affected by the hostile environment created by race-based discrimination.

Additionally, the company must submit to HUD for approval a new nondiscrimination policy and procedure, in English and Spanish. Once approved by HUD, this writing must then be distributed to all employees and residents and prominently displayed in all properties owned and managed by Gene B. Glick Company, Inc. The Company will also provide annual mandatory employee trainings on anti-discrimination laws and trainings for residents on diversity, inclusion, and creating a community of respect.

GLSP's Executive Director Rick Rufolo said, "This is a very meaningful result both for our clients and the community. The amount of damages for each client could produce a real change in their lives to help bring them out of poverty."

"Landlords have a duty to provide tenants with an equal opportunity to use and fully enjoy safe and secure housing. This result will be a wake-up call to those landlords who do not know they can be held liable for tenant-on-tenant race-based harassment," said Alison Slagowitz, Equal Justice Works Georgia Housing Corps Fellow hosted by the Savannah Regional Office of GLSP.

### 5 Ways to Prepare for Mediation

Yes, you should PREPARE for Mediation. This is your one chance to resolve this conflict BEFORE trial, so here's how to give it 110% effort.

- Get all your paperwork printed and organized in a file. A pet-peve of mine is to watch parties who bring in NOTHING, try to call for help, text for help, or find things on email. This wastes everyone time. Having things stored on a laptop seems techy, but laptops run out of battery, and you can't easily make notes on the fly. PRINT it out!
- Know your case. You'll be asked to give a brief summary of why you're here (in mediation). Prepare a 2-3 sentence summary.
- Rest up the night before, get a good sleep, and prepare emotionally. Often, just the thought of conflict can make people angry, emotional, distraught, or all the above.
- Know that Mediation is exhausting mentally and emotionally- yes for us lawyers too. Carve out a whole day free from other client obligations, court dates, and meetings-or anything else that requires your sharpest thinking.
- Prepare to negotiate. 50% of mediations settle, but ALL have the potential to settle or end in agreement. Come into the mediation with the mindset of giving a little to gain a lot.
