

# SBA Holds September Luncheon

The Savannah Bar Association held its monthly luncheon at the Savannah Golf Club on September 21, 2023. At the outset of the luncheon, T. Mills Fleming of HunterMaclean read a resolution in honor of the late Lee C. Mundell, who passed away on June 26, 2023.

Our guest speaker was Travis Spangenburg, Creative & Production Manager at the American Prohibition Museum in Savannah. Travis discussed the history of Prohibition, which began with the passage of the Eighteenth Amendment in 1919, was enforced by Andrew Volstead's National Prohibition Act of 1919, and ended with the passage of the Twenty-First Amendment in 1933.

Travis also explained the reasons Savannah was chosen for the location of the Prohibition Museum. He noted that the 1735 decree banning alcohol in the Colony of Georgia was the first



instance of prohibition in British North America. Additionally, on August 16, 1923, the largest federal raid in Prohibition history broke up a powerful bootlegging ring in Savannah, resulting in over 120 indictments. The SBA thanks Travis for a spirited history lesson!

## Giants of Law Who Did Cases Pro Bono

## Part V: Expanding Access to Justice

In Parts I-III, we discussed lawyer-presidents who represented clients pro bono as part of the regular law practice. In Part IV, we discussed other famous lawyers throughout US history who also weaved pro bono into their regular practice.

This final installment gives a shout out to famous lawyers who either worked in public interest law, serving indigent clients on a daily basis or who helped to move forward the right for those unable to pay for legal representation. This article finishes with four legal issues that were moved forward because of the pro bono work of everyday lawyers.



*In recognizing the humanity of our fellow beings, we pay ourselves the highest tribute..* -- Thurgood Marshall

**Thurgood Marshall** (1908-1993, Associate Justice of the Supreme Court of the United States) received his law degree from Howard University, where he was encouraged by his mentor, Charles Hamilton Houston to view the law as a vehicle for social change. He was admitted to the Maryland Bar in 1933. He initially began as a solo practitioner. By 1935,

Marshall was litigating cases for the NAACP pro bono. In one of his first cases, *Murray v Pearson*, 182 A. 590 (1936), he sued the University of Maryland Law School for denying Black applicants admission into the school. He successfully argued that the law school's admission policy violated the 14th amendment. Shortly after that case, Marshall went to work for the NAACP full time. In 1940 he was named the director-counsel of the NAACP Legal Defense and Educational Fund. He became the leading civil rights attorney in America. He argued 32 cases before the Supreme Court of the United States, winning 29 of those cases including Brown v. Board of Education, 347 US 483 (1954).<sup>[1]</sup>

**Richard M. Nixon** (1913-1994, 37th president of the United States) took some pro bono cases early in his legal career during the Great Depression when clients could not afford his hourly rates (which started at \$1/hour). But he earned his spot on this list for signing the

Legal Services Corporation Act of 1974. Work on the legislation began in 1971, when Nixon sent a special message to Congress proposing the creation of the Legal Services Corporation: an independent agency that would support

legal aid lawyers in their efforts to protect the interest of their clients. LSC is the largest grantor of civil legal aid in the country.<sup>[2]</sup>

**Hillary Rodham Clinton** (1947-, 67th United States Secretary of State) practiced law for 20 years before becoming first lady of the United States in 1993. In 1974, she joined the faculty of the University of Arkansas Law School. She established and was the first director of the law school's new clinical program. When LSC money became available in 1977,

Clinton applied for a grant and the clinical program became Ozark Legal Services (now Legal Aid of Arkansas). Clinton was appointed by President Carter to the LSC Board in 1977 and became the chair of the board in 1978. During her time on the LSC board, LSC's budget increased from \$96 million to \$321 million.<sup>[3]</sup>

**Ketanji Brown Jackson** (1970 - , Associate Justice of the Supreme Court of the United States) earned her law degree in 1996. She has spent most of her legal career in public service. She spent two terms on the US Sentencing Commission, reshaping federal sentencing policy. She also worked as a federal public defender in Washington, DC. She represented indigent clients and Guantanamo Bay detainees.<sup>[4]</sup>

Although this series has discussed pro bono work done by famous lawyers, it may seem that pro bono is only for famous lawyers, consider some important issues in the last 20 years that have been championed by pro bono lawyers across the country.<sup>[5]</sup>

The fight for **marriage equality** was litigated across the country by thousands of pro bono lawyers before making its way to the Supreme Court in *Obergefell v. Hodges*, 576 US 644 (2015).

The fight for **compensation to the victims of 9/11** was spearheaded by a group of lawyers who recruited over 1,000 pro bono attorneys across the country. Those lawyers assisted over 1,700 families across the US and the world to recoup losses and bring closure to an event that rocked the world.

Hundreds of pro bono attorneys represented **detainees at Guantanamo Bay** who could not afford representation. Those pro bono attorneys challenged the federal government for holding detainees indefinitely. Pro bono lawyers also pressured the US Senate to release the CIA Torture Report which reviewed the CIA's program to transfer terrorism suspects to countries known to use torture.

More than half of the states have enacted **restrictive voting laws**, many of these laws require voters to present photo IDs and limit access to polling stations, mail-in ballots, and early voting. These laws disproportionately affect the elderly, people of color, people with disabilities, and those with low-income. These are groups that may not have the forms of identification required to cast a ballot or have limited transportation making it difficult to get to distant polling stations. Pro bono lawyers around the country challenge these laws to protect everyone's constitutional right to vote, regardless of race, political affiliation, or economic status.

The Staff Attorney will perform client intakes, provide referrals, advice, brief services, and/or representation. - Ability to speak Spanish is a plus.

#### **Qualifications:**

- Demonstrated interest or experience working with clients on poverty law issues and public benefits law.
- Willingness and ability to work as part of a team in a professional and collaborative manner.
- Computer literacy, which includes familiarity using email, Microsoft Office, Legal Server, and other computer programs.
- Ability to work with diverse populations, backgrounds, and perspectives.
- Excellent oral advocacy, research, and writing skills.
- Attention to detail and self-motivated.
- Ability to analyze, write, and present ideas and legal concepts clearly and concisely.
- Computer literacy, which includes familiarity using email, Excel, Word, SharePoint, Legal Server, and other computer programs.

Starting Salary: \$55,000 - \$74,650, depending on experience.

**About the Position:** This position is located at U.S. Army Garrison (USAG) Fort Stewart, Installation Legal Office, Fort Stewart, Georgia.

If you are currently serving in a permanent, competitive service appointment in the Federal service, and are selected for this position, the appointment will remove you from the competitive service while you occupy this position.

#### Duties

- Provides professional legal advice and assistance in cases often involving unique and very difficult legal questions, or factual issues with few or conflicting precedents involving the public interest.
- Assists military personnel to prepare their explanatory statements, appeals or requests for reconsideration on report of survey charges.
- Prepares rebuttals to bars to reenlistment and appeals of efficiency reports for presentation to the reviewing authority.
- Conducts legal review and provides advice during emergency deployment readiness exercises and Soldier Readiness Checks.
- Assists service members who leave civilian jobs to go on active duty under the Uniformed Services Reemployment Rights Act.
- Keeps abreast of legislation, opinions, regulations, court decisions, circulars, and authoritative legal opinions necessary for mission accomplishment.
- Practices preventive law by preparing articles and presenting classes on recurring legal problems.
- Conducts SJA functions in implementing the command preventive law program, and coordinates with other staff sections involved.
- Trains and mentors attorneys in the Office of the Staff Judge Advocate regarding substantive and procedural legal issues and questions
- Manages, plans, organizes, coordinates, implements, and operates the Legal Assistance Casualty Assistance and Survivor Benefits Program.

#### Requirements

Conditions of Employment

- Appointment may be subject to a suitability or fitness determination, as determined by a completed background investigation.
- A two year trial/probationary period may be required.

## Who May Apply: US Citizens

Applicants will be evaluated to determine if they meet the minimum qualification requirements and on the extent to which their application shows possession of the following knowledge, skills and abilities (KSAs) associated with the position.

#### KSA's:

- Skill in identifying and researching highly technical and complex legal issues.
- Skill in providing legal, technical, and policy guidance to individual clients.
- Ability establish and maintain client confidentiality, and avoid conflicts of interest or the appearance of a conflict of interest, in accordance with applicable law and Army Regulations.
- Ability to effectively, professionally, and ethically manage a heavy caseload of clients with complex legal needs.
- Ability to work with multiple legal offices on a daily basis.

- Ability to work cooperatively as part of a team and/or lead a team to resolve issues.
- Ability to express information (for example, ideas or facts) to individuals or groups effectively, taking into account the audience and nature of the information (for example, technical, sensitive, controversial); makes clear and convincing oral presentations; listens to others, attends to nonverbal cues, and responds appropriately.
- Ability to maintain effective working relationships with agency staff at all levels as well as with key individua

**Qualification Requirements:** The following minimum qualification requirements must be met before applicants are eligible for further consideration:

**Education Requirements:** Position requires the possession of the first professional law degree (LL.B. or J.D.) AND a member in good standing with the highest court of a State, U.S. commonwealth, U.S. territory, or the District of Columbia. Applicants for initial appointment into attorney positions within the Department of Army must be graduates of law schools accredited by the American Bar Association at the time of the applicant's graduation. As indicated below, a law school transcript must be submitted with your application materials.

**Bar Membership:** Applicants must currently be a member in good standing (as defined by the pertinent bar) of the bar of the highest court of a State, U.S. territory, the District of Columbia, or Commonwealth of Puerto Rico. As noted below, proof of such membership and good standing must be submitted with your application materials.

**Experience:** In addition to the requirements above, applicants for the GS-13 or equivalent Attorney positions must also possess 2 years of professional legal experience, acquired after being admitted to the bar, commensurate with the duties and responsibilities of the position. Graduation from an ABA-Accredited Law School in the top 25% of the class or an advanced law degree such as an LLM may substitute for one year of the required professional legal experience.

Time in Grade: The Qualifying Authorities (QA's) will make a determination as to the applicability of time in grade based on the requirements of the position. If you are currently employed as an attorney by the Federal



government you must have completed one year at the next lower grade level within 30 days of the closing date of the announcement, or previously served at the same or higher grade level as the position being filled.

NOTICE OF VETERAN'S PREFERENCE: There is no formal rating system for applying veteran's preference to attorney appointments in the excepted service; however, the Department of the Defense considers veterans' preference eligibility a positive factor for attorney hiring. Applicants eligible for veterans' preference must include that information in their cover letter or resume and attach supporting documentation (e.g., DD Form 214, "Certificate of Release or Discharge from Active Duty") to their submissions.

Although the point-preference system is not used, applicants eligible to claim a 10-point preference must submit a Standard Form (SF) 15, "Application for 10-Point Veteran Preference", and supporting documentation required for the specific type of preference claimed. The SF 15 will identify the supporting documentation required along with the list of the types of 10-point preference. The SF 15 is available from the OPM at <u>https://www.gsa.gov/portal/forms/type/sf/</u>.

#### Education

Only degrees from an accredited college or university recognized by the Department of Education are acceptable to meet positive education requirements or to substitute education for experience.
